 Contractor. The Delivery Partner is an independent contractor with
 CompTIA for the activities associated with the Program and limited to

 Delivery Partner shall not hold itself out as being CompTIA, or an
 affiliate or instrumentality of CompTIA, and may only represent that it is

- A. Discounted Pricing. CompTIA will provide to Delivery Partner discounted pricing on CompTIA Products in accordance with the pricing schedule provided in Schedule 1.

- D. Certification Testing. Delivery Partner will offer learners in a CompTIA Training Class the option to take any CompTIA certification exam either (i) through an online testing provider (as pre-approved in writing by CompTIA) or (ii) at a physical Pearson VUE testing site. If Delivery Partner is a test delivery provider, Delivery Partner agrees to maintain its status as a Pearson VUE testing site throughout the duration of the Term.
- E. Marketing and Co-Branding. Delivery Partner acknowledges that CompTIA has dedicated significant resources to CompTIA's branding and intellectual property, and agrees to promote the value of CompTIA certifications and the suite of available CompTIA Products, including in marketing materials, websites, and other collateral in compliance with the Trademark Policy located at www.comptia.org/legal.
- F. Notice of Pricing Changes/New Product Pricing. CompTIA endeavors to provide Delivery Partner written notice of changes to Delivery Partner Pricing for CompTIA Products at least thirty (30) days in advance, which notice will also include updated expiration dates. On the day immediately following the respective expiration dates, Schedule 1 will be automatically superseded and replaced by such updated Delivery Partner pricing for CompTIA Products and expiration dates without any requirement for the parties to execute an updated Agreement, Exhibit, or Schedule 1.
- G. The foregoing written notice shall supplement and/or override if applicable (i.e., where a New CompTIA Product is intended to replace an existing CompTIA Product) Schedule 1 without any requirement for the Parties to execute an updated Schedule 1.
